Father Bauza performed the ceremony after which a reception was held at the home of the bride. "Ana" as she is familiarly known, was dressed in a sheer white gown with a long train and carried a bouquet of white calla lilies. Nemesio wore a white suit.

Unit members had a special interest in this wedding because Nemesio is one of our cooks in the kitchen. Incidentally, he baked his own three tiered wedding cake.

BRETHREN ACADEMY

The Brethren Academy's tenth grade is running smoothly now in its sixth week. Enrollment was limited to thirty-three at the end of the first week and has now dropped to thirty, which is the number we thought we could accomodate adequately. Classes are continuing in the Llinas Casa Grande but the school building at the grass plot on the Grillasca Road is nearly ready for occupancy.

We are petitioning the Department of Education for recognition of our school which we hope may be realized by the end of the first semester.

With the opening of the school year comes the School Health Program, that the Unit has been sponsoring for a number of years. There are eight first unit or common schools, two junior high schools, and one high school which we are attempting to serve this year.

The moving work continues. The first building of the school is nearly ready for occupancy. The cement foundation and floor of one wing of the hospital is poured.
